

1 Log in via www.v-next.cn, then click "**Register**".



Choose your identity as "Enterprise". 选择**"项目方"**身份。




Fill in required information and click to submit. The account will be activated after the verifying process. 填写相关信息后,提交注册申请。通过审核后,账号会被激活。




2 Start your V-Next journey by clicking **"Add enterprise"**. 点击**"新建项目"**,即可开始注册项目。



You need to complete all the required information in the following 3 sections: company information, financing requirements and financial index.







2. HOW DO I RECOMMEND PROJECTS? | 2. 项目注册


Click **"Countries"** on the homepage, you can view basic information about countries in V-Next network with enterprise.








6. HOW TO VIEW AND SHARE IN "REGIONS" SECTION 6. 区域专题内容查看与分享

Click "**Regions**" on the homepage, you can access basic information about different regions with brief project introduction.


