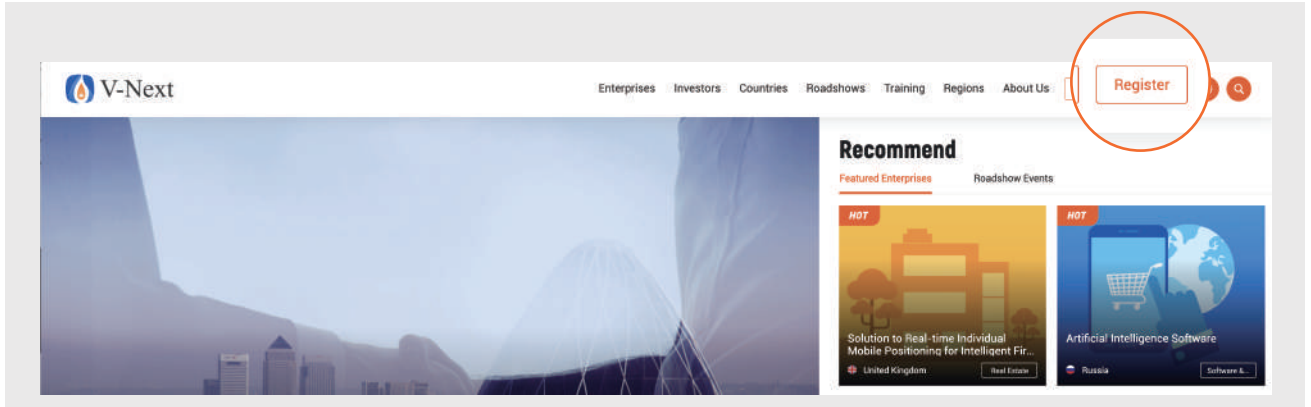

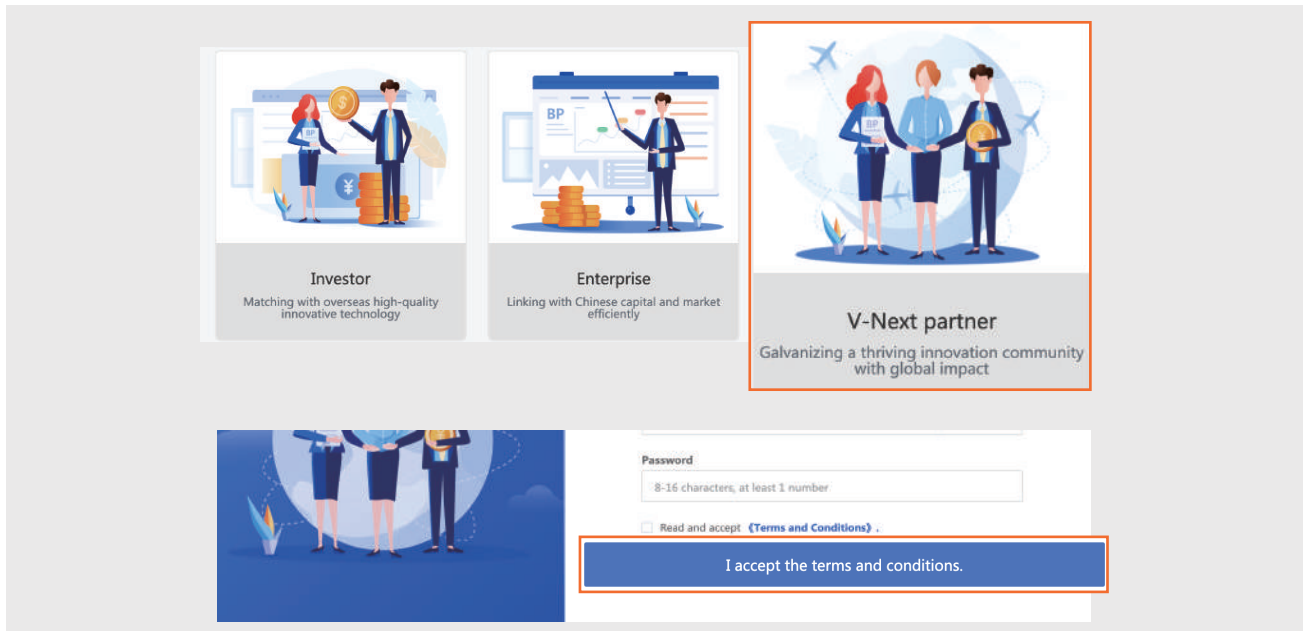

1. HOW DO I REGISTER? | 1.注册指引

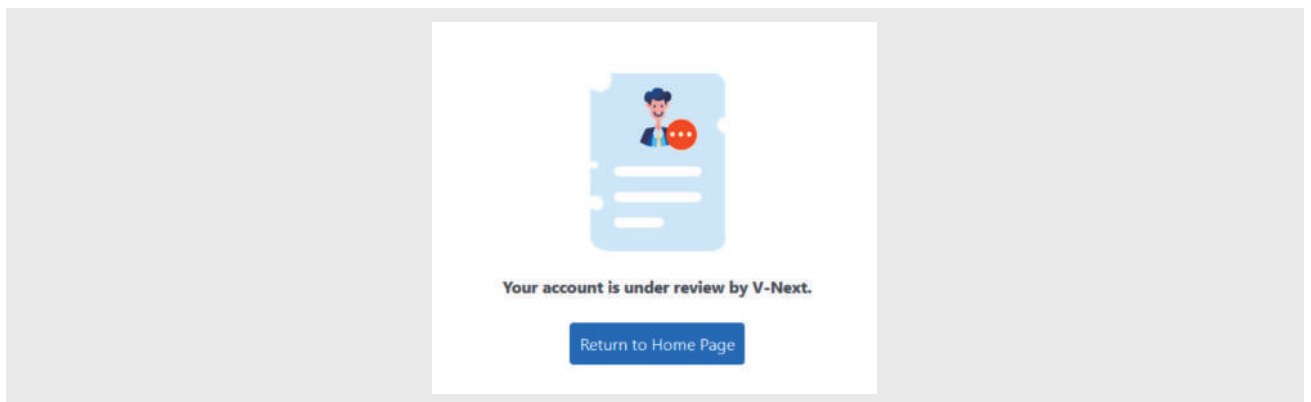
- 1 Log in via **www.v-next.cn**, then click **“Register”**.

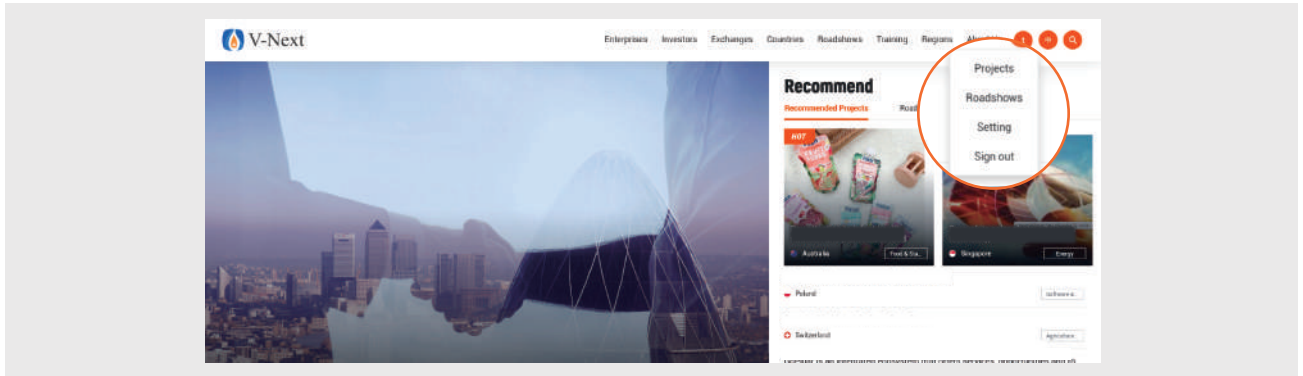


- 3 Once you submit, your account will be reviewed by V-Next team.

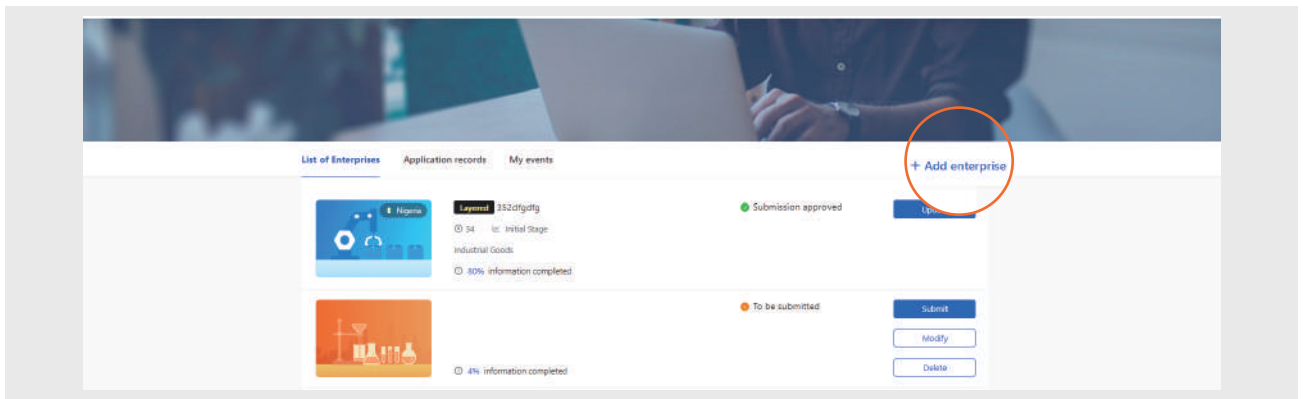

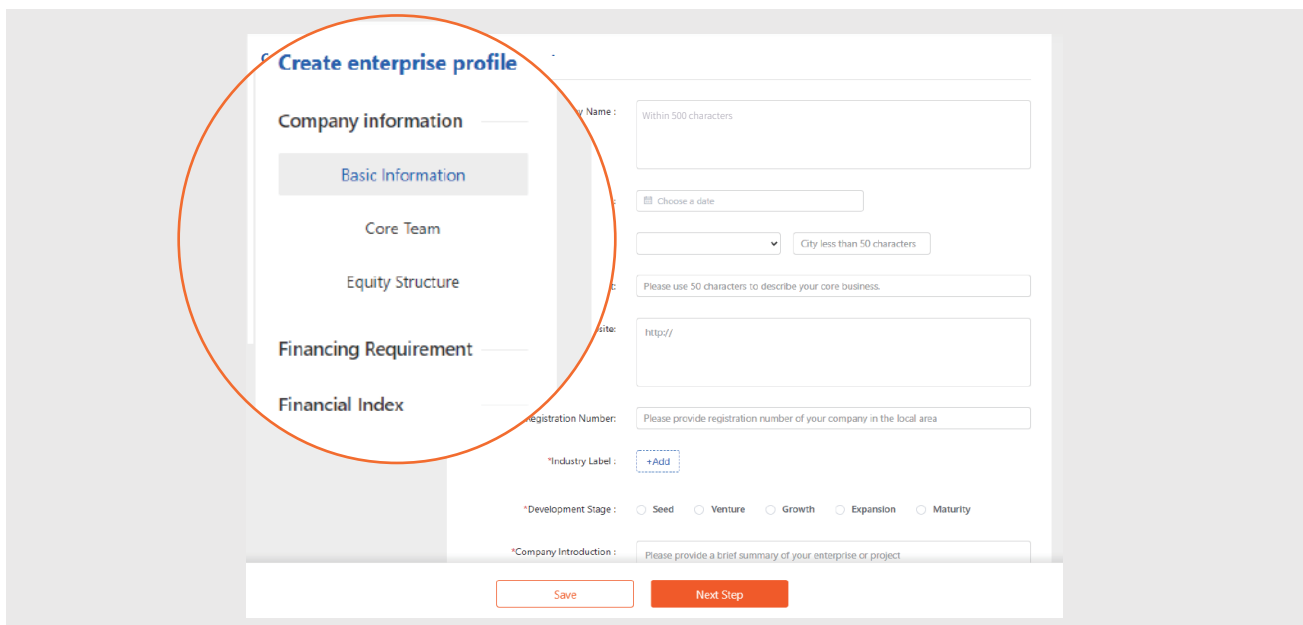
- 1 Log in and click the profile photo, choose **“Project”**.

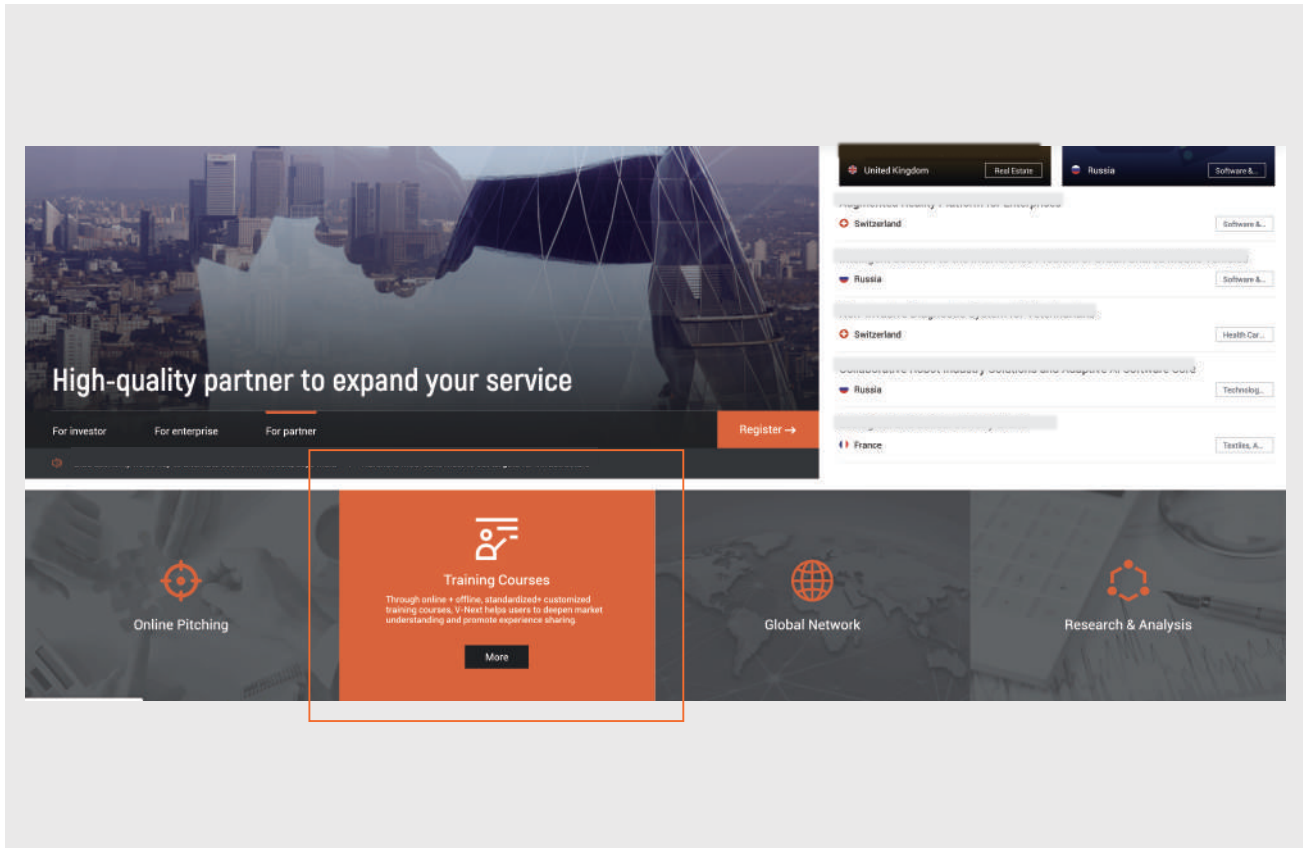

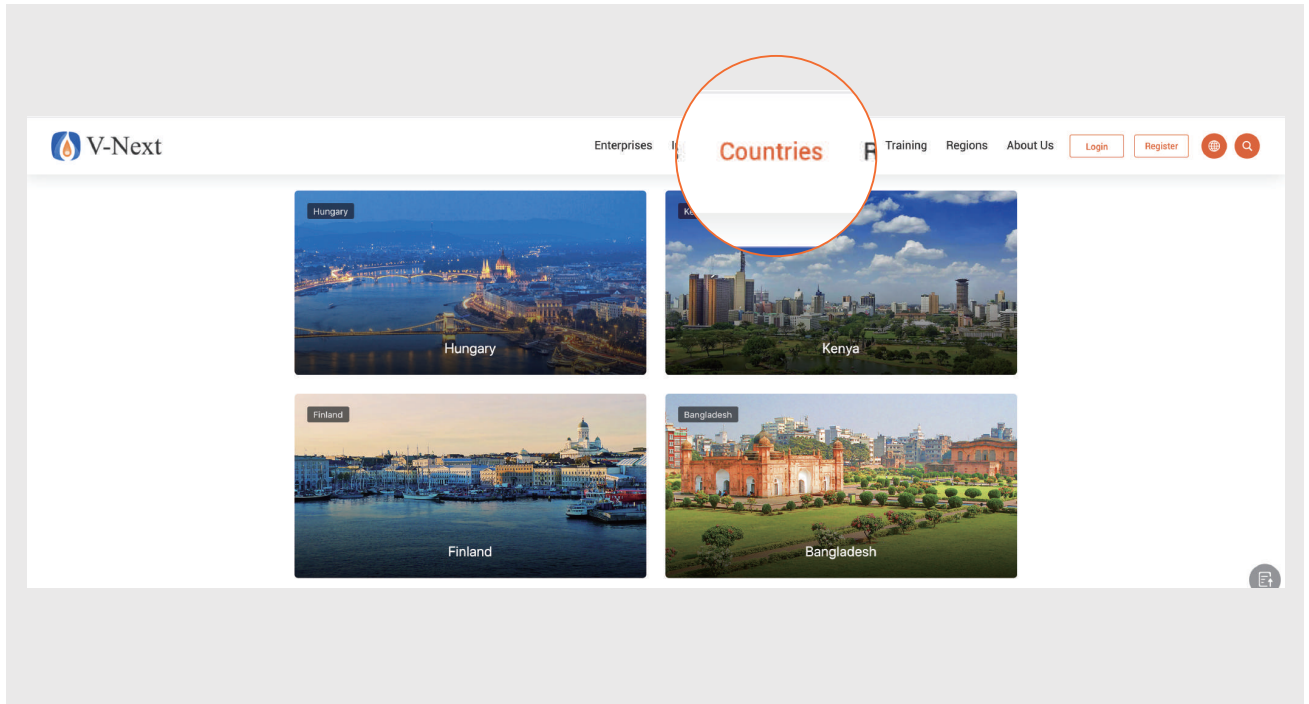

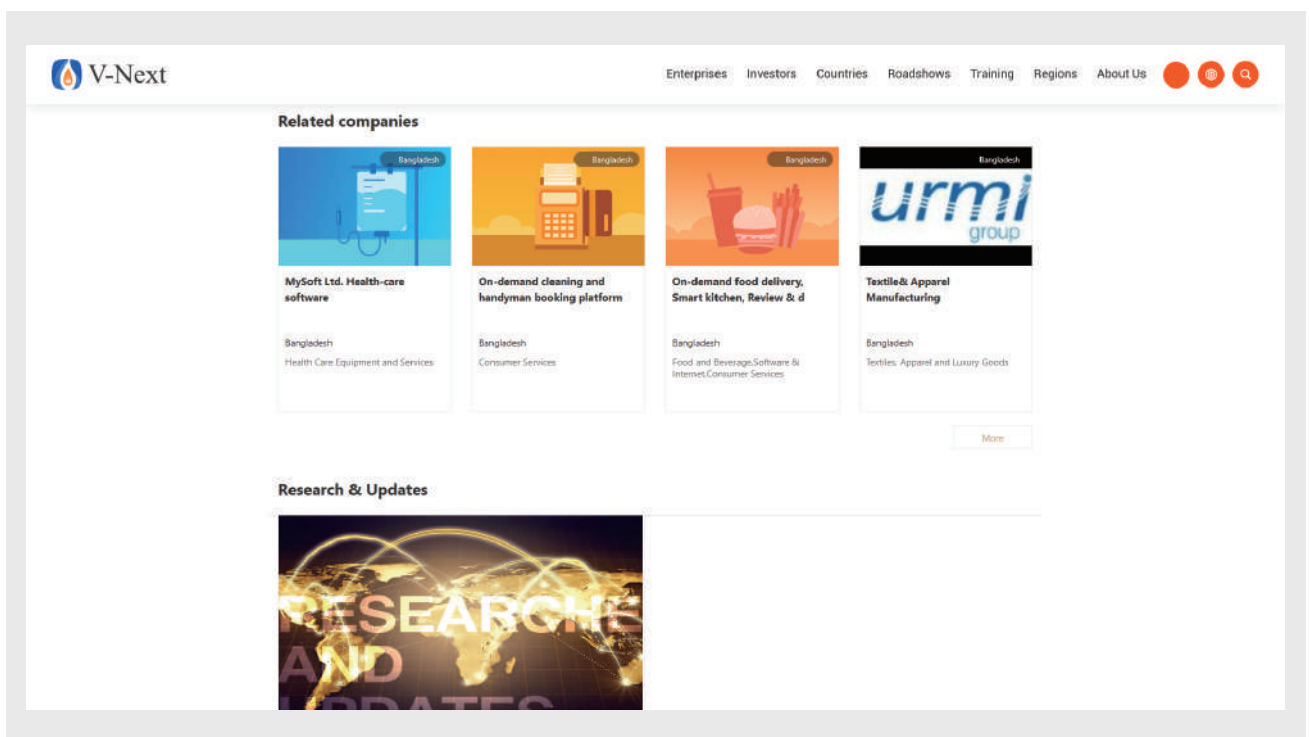

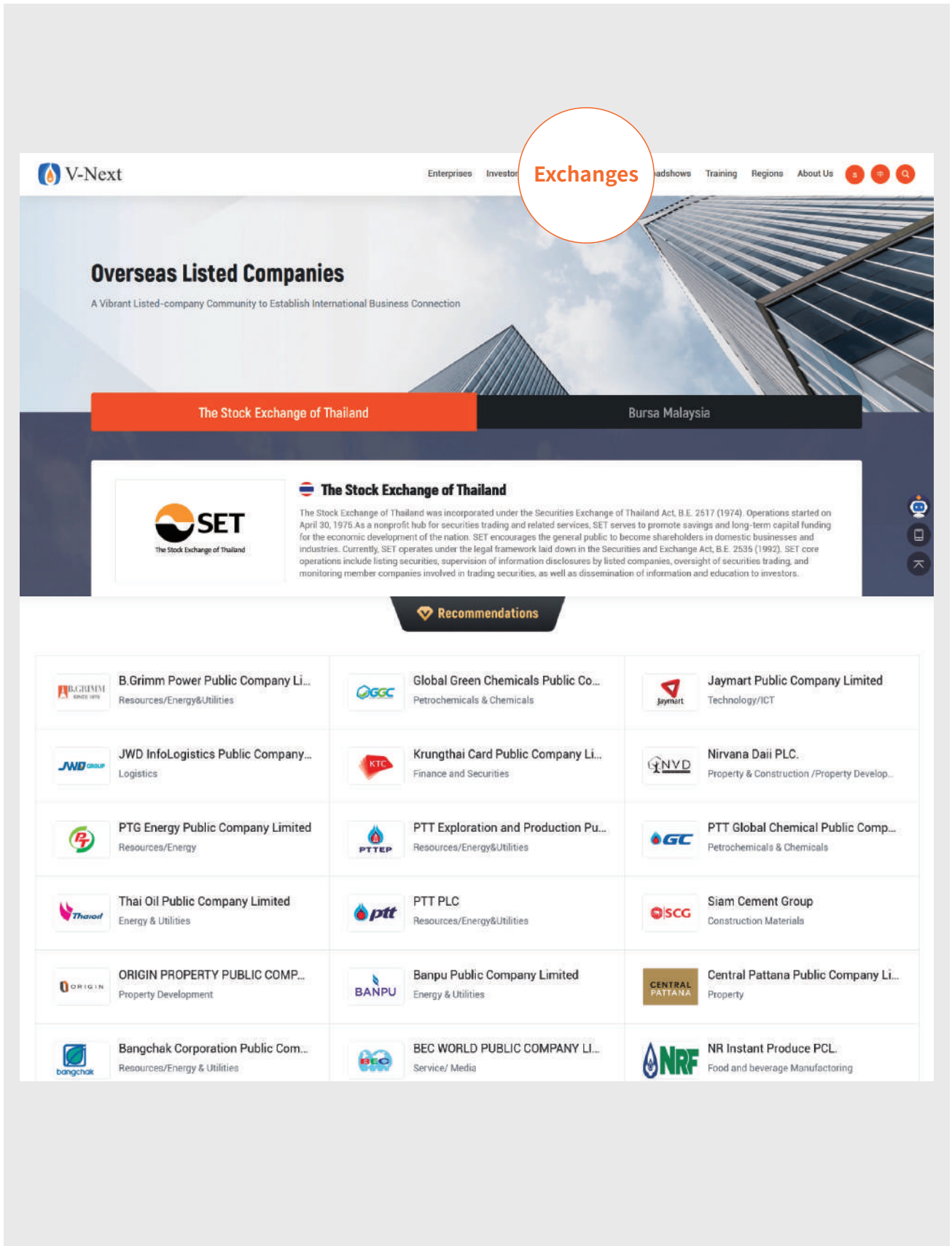

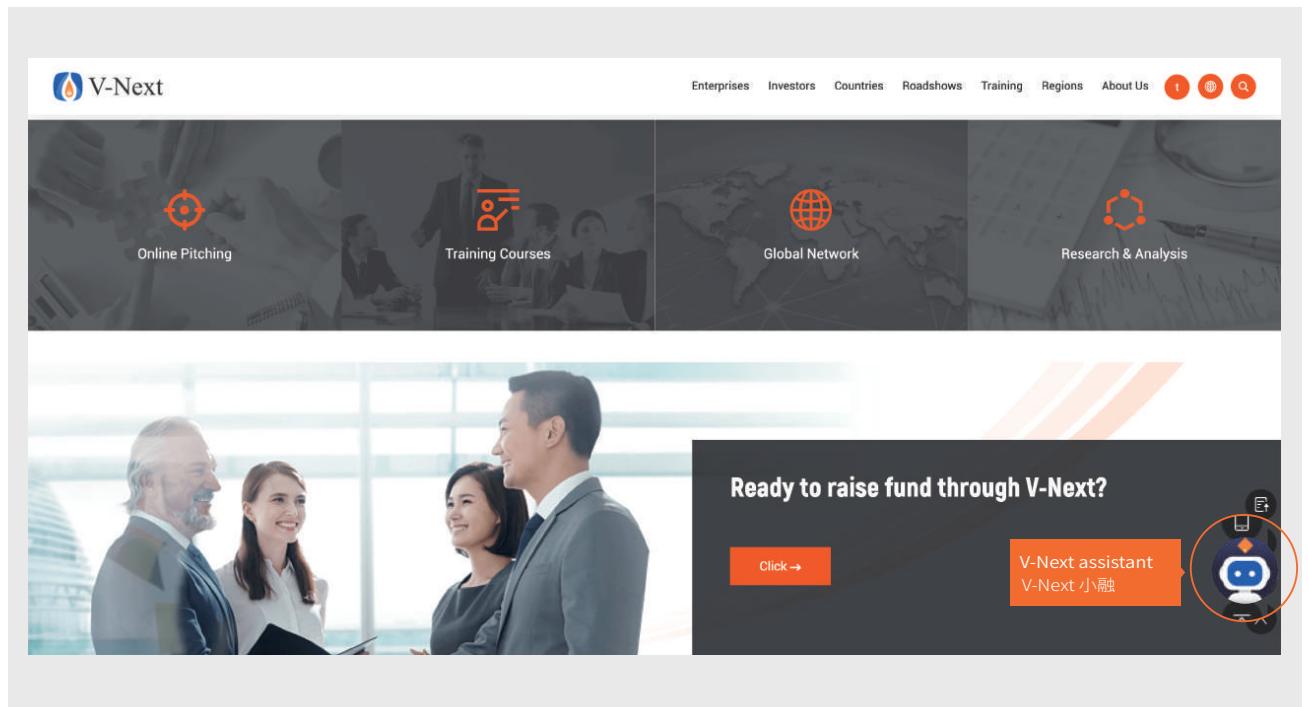
